

THE SUBMISSION CHECKLIST FOR MANUSCRIPTS
sent through the webpage
International Problems/Međunarodni problemi

1. Get acquainted with the *Instructions for the Authors, the Responsibilities of the Authors* and other policy documents available at the [Journal webpage](#);
2. Make sure that your manuscript meets the standards and criteria outlined in the aforementioned documents;
3. Technical steps:
 - a. on the [Journal webpage](#), go to the menu section “FOR AUTHORS”;
 - b. select option “Send manuscript (through WEBPAGE)”;
 - c. register your personal account by clicking on the icon “Registration”;
 - d. if you already possess an account, log in and follow the necessary steps

*****Note: in case of forgotten password, click on the option “forgotten password”. It is FORBIDDEN to register multiple accounts, in order to prevent doubling your data in the database!**

- e. during the manuscript submission, it is obligatory to give consent with *Author statements* by ticking the designated box. The content of *Author statements* is visible on the second page of this file.
- f. during the manuscript submission, it is obligatory to give consent with *Licence Agreement* by ticking the designated box. The content of *Licence Agreement* is visible on the third page of this file.
- g. fill out all required fields and upload files: *Cover page* and *Anonymized file* with the manuscript text (in .doc or .docx format).

*****Note: make sure that the file name of the anonymized manuscript document doesn't contain your personal details, like name(s)! It suffices to just state the article title, for instance: *Manuscript_EU_at_the_crossroads.docx*.**
